However, by signing this form, the undersigned is willing to assume those risks and release, hold harmless, and indemnify On Stage Dance Studio, its related entities, agents, employees, officers and representatives from and against any and all claims, demands, actions, judgments which the undersigned, or any person ever had, or may have against On Stage Dance Studio, for any losses, costs and expenses (including attorney's fees) and damages or injuries known or unknown, real or personal, sustained by me or my child while in attendance and/or participating in all On Stage Dance Studio programs.
